Scaled tenders are invited for the following works at CIMFR , Digwadih Campus, P.O : FRI, Dist- Dhanbad & CIMFR, Raniganj unit from approved and eligible civil contractors of CPWD, PWD, MES, RAILWAYS , P&T Department and from those who have carried out similar work in CSIR or Govt / Semi Govt organization and reputed organization etc fulfilling the following requirements.

- 3) Experience of having successfully completed Three, Two or One similar type of work for an amount equal to 40% , 50% , or 80% of estimated cost respectively during last seven years ending last day of month previous to the one in which tender were invited .
- 4) Latest Valid Sales Tax clearance incl. sales tax registration certificates, PAN card for Income Tax etc. Tender papers will not be issued by postal arrangements.

Estimate based on DSR-2007 & Market rates. **Similar work means construction / maintenance of civil works.**


Tenders will be received in the office of the Administrative Officer, CIMFR, Digwadih campus up to 3.00 PM on 11.07.2011 and will be opened on the same day at 3.30 PM in presence of tenderers or their authorized representative who may wish to be present.


The tenderers shall not be permitted to tender for the job in the concerned unit of CSIR in which a relative is posted in the grade between Controller of Administration and Junior Engineer (both inclusive). He shall also intimate the names of persons who are working with him in any capacity or subsequently employed by him and who are related as mentioned above. Attested copies of up to date and valid sales tax clearance certificate, Income tax, PAN, relevant work order including completion certificate will be enclosed along with tender application form separately for each work. The original certificates will have to be produce at the time of issue of the tender paper. Late tenders will be summarily rejected.
