Sealed tender is invited for the following work at CIMFR, Digwadih campus, P.O : FRI, Dhanbad and CIMFR unit Ranchi, Namkum from approved and eligible Electrical/Mechanical/Civil contractors of CPWD, PWD, MES, Railways, P & T Department and from those who have carried out similar work in CSIR or Govt / Semi Govt organizations and reputed Organization etc fulfilling the following requirements :

- i. Experience of having successfully completed Three, Two or One similar type of work for an amount equal to 40 % , 50 % , 80 % of estimated cost respectively during last seven years ending last day of month previous to the one in which tenders were invited.
- ii. Latest valid Sales Tax clearance incl. sale tax registration certificates, PAN card for income Tax & Service Tax and License for Electrical works etc wherever applicable.

Income tax , sale tax & others etc in respect of contract works will be deducted at sources as per rules. Performance Guarantee will be deposited by the lowest quoting firm before awarding the work as per rules. Estimate is based on DSR-2007 & Market rates.

For Sl. No. 5 tender to be submit in two bid system ie, Part-I (Techno- commercial Bid) & Part-II (Price Bid). Part-I (Techno Commercial Bid) consists of i) proof of documents as mentioned above, ii) Earnest Money & iii) Technical specification of DG set in detail. Part-II (Price Bid) consist of costing of the items involved in the work including taxes & levies etc as per different laws. For Sl. No. 5 Part-I (Techno Commercial Bid) will be opened on 21.12.2009. Selected tenderers will be informed Officially for opening the Part –II (Price Bid) in due course.

The contractors shall comply with all the provisions of the minimum wages act 1948, Contract Labor (Regulation and Abolition Act) 1970 including scheme acts wherever applicable.

Tenders will be received in the Office of Administrative Officer, CIMFR, Digwadih campus, P.O : FRI, Dhanbad up to 3.00 PM on 21.12.2009 and will be opened on the same day at 3.30 PM in presence of tenderer or their authorized representative who may wish to be present.

The tenderers shall not be permitted to tender for the job in the concerned unit of CSIR in which a relative is posted in the grade between Controller of Administration and Junior Engineer (both inclusive). He shall also intimate the names of persons who are working with him in any capacity or subsequently employed by him and who are related as mentioned above. Attested copies of up to date and valid sale tax clearance certificate , income tax, PAN, relevant work order along with completion certificate will be enclosed along with each tender application form. Late tenders will be summarily rejected. Similar works means Supplying, Installation, Testing and Commissioning of Silent type DG set for Sl. No. 5 and PVC flooring or equivalent for Sl. No. 6.
