Sealed tender are invited for the following works at CIMFR(DC), P O, F.R.I, Dhanbad from approved and eligible civil contractors of CPWD ,State PWD ,MES, RAILWAYS , P&T Department and from those who have carried out similar work in CSIR or Govt/ Semi Govt organization etc fulfilling the following requirements.

1) Experience of having successfully completed Three, Two or One similar type of work for an amount equal to 40%, 50%, or 80% of estimated cost respectively during last seven years ending last day of month previous to the one in which tender were invited.

2) Latest Income Tax clearance and valid sale tax registration certificates.

Tender papers will not be issued by postal arrangements. Income tax & Sale tax etc in respect of contract works will be deducted at sources as per rules. **Last date of receiving of application for obtaining tender documents 25/02/2011 up to 4pm.**

Tenders will be received in the office of Controller of Administration, CFRI, and P.O: FRI, Dhanbad up to 3.00 PM on 02.03.2011 and will be opened on the same day at 3.30 PM in presence of tenderers or their authorized representative who may wish to be present.

The tenderers shall not be permitted to tender for the job in the concerned unit of CSIR in which a relative is posted in the grade between Controller of Administration and Junior Engineer (both inclusive). He shall also intimate the names of persons who are working with him in any capacity or subsequently employed by him and who are related as mentioned above. Self attested copies of up to date and valid sales Tax clearance certificate, Income Tax, relevant work order along with completion certificate will be enclosed along with tender application form separately for each work. The original certificates will have to produce at the time of issue of tender papers. Late tenders will be summarily rejected.

The successful tenderer shall be required to submit an amount equal to 5% of the successful tendered value of the contract as performance security within the period prescribed for commencement of the work in addition to the other deposits.

Director, CIMFR reserves the right to reject any or all tenders or accept them in part or the lowest tender without assigning any reasons whatsoever. Interim enquiries will not be entertained.
